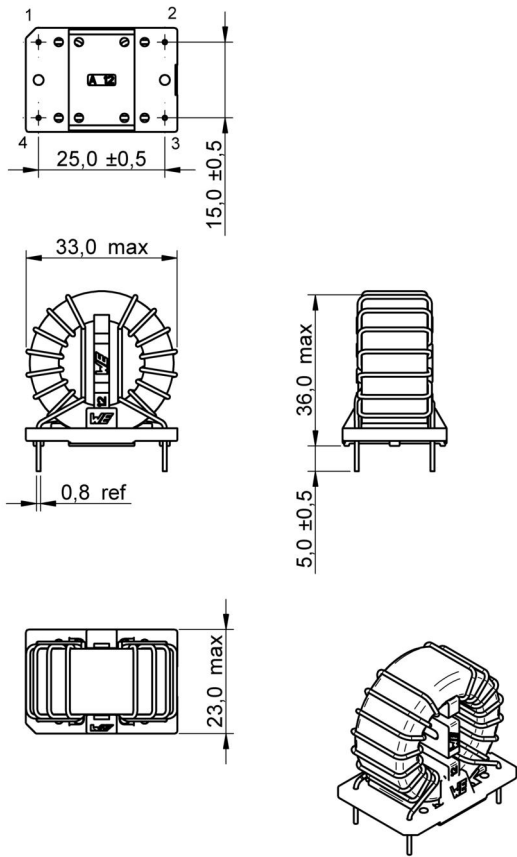
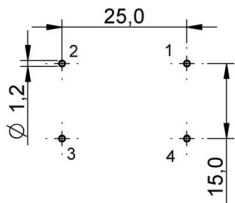

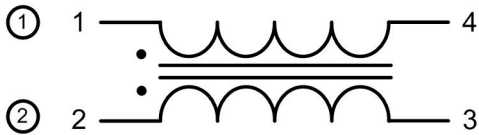

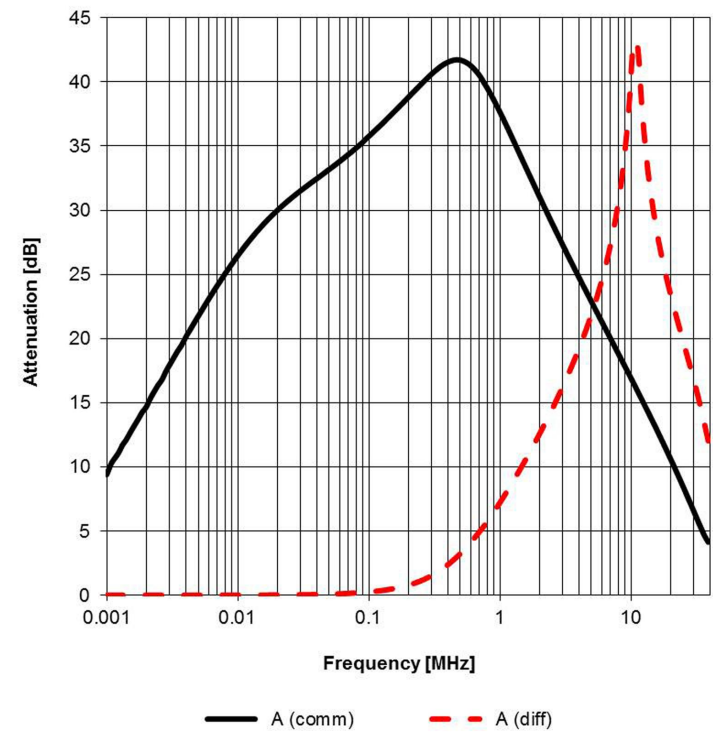

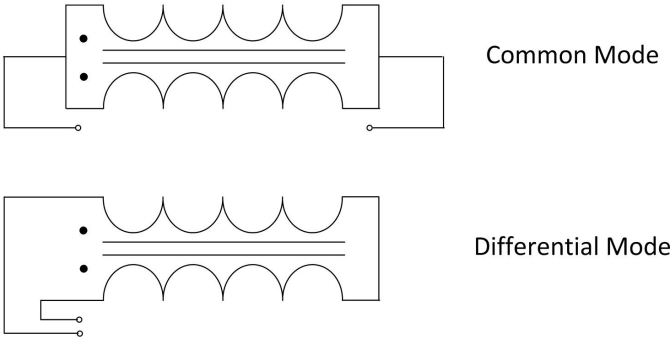

General:

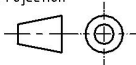
Product specific:
