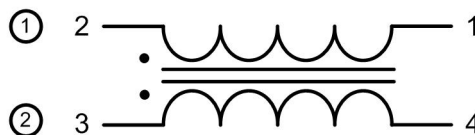
B Recommended hole pattern: [mm]

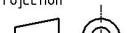
F Typical Insertion Loss Characteristics:



Common Mode

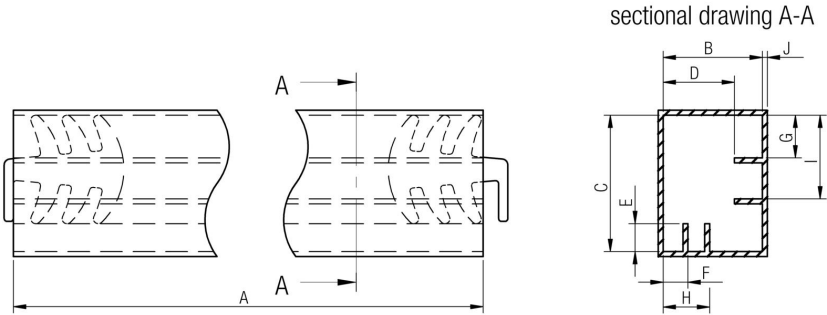


Differential Mode

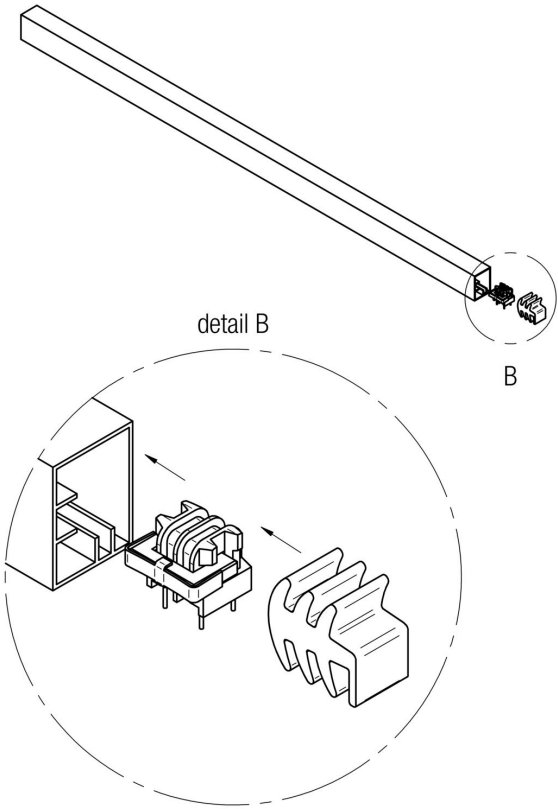

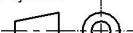

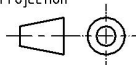
